The type of personal information we collect

We currently collect and process the following information:

- Personal identifiers, contacts and characteristics (for example, name, phone number and email address)
- Meter Point Administration Numbers (MPANs) and Meter Point Reference Numbers (MPRNs) relating to specific sites, including energy usage

How we get the personal information and why we have it

Most of the personal information we process is provided to us directly by you for one of the following reasons:

- To calculate your consumption data for financial modelling (if you are a potential project site)
- To keep you up to date with our activities through our mailing list and other ad-hoc emails
- To record your membership to our group

We may share this information with third parties we have contracted to carry out work on our behalf with your consent.

Under the General Data Protection Regulation (GDPR), the lawful bases we rely on for processing this information are:

• Your consent

You are able to remove your consent at any time

How we store your personal information

Your information is securely stored either on our website provider, Wix.com, or in our password-protected Google Drive.

We keep names and email addresses for up to two years. We will then dispose of your information by deleting it.

Your data protection rights

Under data protection law, you have rights including:

Your right of access - You have the right to ask us for copies of your personal information.

Your right to rectification - You have the right to ask us to rectify personal information you think is inaccurate. You also have the right to ask us to complete information you think is incomplete.

Your right to erasure - You have the right to ask us to erase your personal information in certain circumstances.

Your right to restriction of processing - You have the right to ask us to restrict the processing of your personal information in certain circumstances.

Your right to object to processing - You have the right to object to the processing of your personal information in certain circumstances.

Your right to data portability - You have the right to ask that we transfer the personal information you gave us to another organisation, or to you, in certain circumstances.

You are not required to pay any charge for exercising your rights. If you make a request, we have one month to respond to you.
